- Two prominent planning applications have been dealt with in the year 2022-23 with the application for the development of the Royal Oak public house and the Helios Solar Farm.

The Royal Oak development has been granted permission for up to seven dwellings, with Selby District Council Planning Department working with us and listening to our concerns which has afforded the most amiable plan and development for the site.

The Helios Solar Farm application is still in the midst but a decision is likely to be some time in the future after being considered by the Secretary of State.

 There has been a big change to the council members over the last year with three councillors representing the West Bank community having resigned in 2022. The councillor vacancies have now been filled, with cllr's Harper, Stephenson and Webster joining the Council.
